anent Registration of Probative Writs in all points Which  
desire the said Judge affoud reasonable And therefore  
Ordain the same to be done Accordingly to the Effect foresaid -  
Whereof the Tenor follows, I Doctor Hugh Halcoro  
of Goubister Heritable Proprietor of the Lands & Estate of Goubister  
and otherways having right thereto from William Halcoro late of  
Goubister my deceast father by Disposition of date the thirteenth day  
of March One thousand seven hundred and fifty eight Years under  
the Provisions & Conditions therein expressed And I having now  
attained to the Right and possession of the said Estate And having  
of this days date in Order to settle the Succession thereto And for  
preventing any Differences & Disputes thereanent And for other  
Causes therein mentioned Have made a Disposition of the same  
and pertinents thereto to William Halcoro my only Son and the  
heirs of his body Which failing to the other Heirs & Substitutes  
in the said Disposition in the order of Succession therein express'd  
Subject to the Reservations, Provisions, Conditions, Declarations and  
Limitations therein particularly mention'd containing the usual &

Appointed Joshua Johnston Writer in Stromness, Margaret Halore

and Curators to my said Son and to my other Children if any  
have who may be within the Years of Tutorly or curatory for  
managing the said Estates, Collecting the Rents Mails and Duties  
thereof. And to do other things in relation to the management of the  
said Estate and other affairs in manner and on the conditions thereon  
expressly mentioned. And that the said Nomination may be the more  
Effectual and this present Nomination be used either Separately or  
Jointly therewith. the one without prejudice of the other to the Effect  
above and after mentioned I by these presents hereby again Nominate  
and Appoint the said Joshua Johnston and Margaret Halore  
his said Spouse and Jean Halore my said Sisters or any one  
or more of them on life for the time, to be Tutors & Curators to my  
said Son who is now in Jamaica till he arrives in Orkney And  
thereafter till he arrives at the Age of Twenty one Years compleatly  
and to all my said other Children if any be, that shall be within  
the said Years of Tutorly & curatory after my Death With full  
power to the said Tutors and Curators or any one or more of them  
on life for the time as aforesaid To Intromitt with the Rents, mails  
Duties and Casualties of the said Estates, and with all the money  
and moveable debts Effects and other things whatsoever belonging  
or due to me within the Country of Orkney at the time for said of  
my Death or that was left to me after my said Father or otherwise

4<sup>th</sup> Provisions & Obligations and other things I hereby empower the said

 them on life for the time to Raise or Borrow money from any person  
 or persons who shall lend the same, and to Grant Securitys therefore  
 upon all or any part or parts of the said Lands & Estate containing all  
 Clauses needfull with absolute Warranties upon my said Son or his  
 foresaids and upon the rest of the Heirs intitled to the Succession of  
 the said Estates And to Bind them to Repeal and pay back the said  
 Sum or Sums so borrowed and Interest and Penallys thereof that may  
 be due, and for which the said Securitys shall be granted at such term &  
 on such Conditions as shall be agreed betwixt the said Tutors & Curators  
 or either of them as said is, And the Party or Partys Lender And also  
 to settle with the Liferenters Annuitants or others provided & intitled  
 to any Liferent Annuity or other Provision out of the said Estate  
 for such Liferent Term or Terms greater or lesser and Annuitys  
 or to the Provisions as are or may be due and payable to them upon  
 such terms as shall be agreed with the Party or Partys intitled thereto
